Madam/Sir,

This is in continuation to this office Letter number PCH-RGSA/5/2021/-RGSA-GoHP- 1767-1781 dated 18<sup>th</sup> January 2022 on the aforementioned subject. Following clarification may kindly be taken into consideration:-

- a) Participants will be Elected Representatives of Gram Panchayats, Panchayat Samitis, and all Officials of Gram Panchayats, Panchayat Samitis along with fonctionneries.
- b) Participants from Self Help Groups, Mahila Mandals, Yuvak Mandals, Line Departments and NGOs can also be included.
- c) In case of online training, Rs. 200/- per participant per day will be given as sitting charges. Balance shall be retained as user charges and has to be deposited in the zero based new account of Indusind Bank by the name of DPRC /training centre / DPO office and will be used for support for need based creation of training infrastructure and facilities in the training including other office expenses.
- d) Top priority should be given to impart training on 15<sup>th</sup> Finance PFMS expenditure software, RGSA PFMS SNA Software and other topics as conveyed vide this office letter no PCH-RGSA/5/2021/-RGSA-GoHP- 1767-1781 dated 18<sup>th</sup> January 2022.
- e) PRTI Mashobra, Thunag and Baijnath will also impart training to **Clusters of Model GPs** falling within their jurisdiction and will keep separate data to submit further before MoPR and NIRD Hyderabad.
- f) Principal PRTI Mashobra is also requested to in touch with MoPR New Delhi to make Training Management Portal functional and also inform field offices accordingly.
- g) Zero Base Bank Account of Indusind Bank may be opened for transferring fund of user charges.
- h) Since limits has already been fixed as per guidelines of Ministry of Finance under SNA, you may withdraw funds as per your requirement under SNA.
