



## Minutes of the meeting to discuss LSDGs (Localization of Sustainable Development Goals) based on nine themes.

Meeting to discuss the strategy and future course of action regarding Localization of Sustainable Development Goals (LSDGs) and 09 themes was held under the chairmanship of Director-cum-Special Secretary(Panchayati Raj) on 05th September, 2022 in his office Chamber. The list of participants is at Annexure-A.

At the outset the chairman welcomed all the participants. Thereafter, Joint Director, Panchayati Raj gave a presentation regarding overview of Revamped Gram Panchayat Development Plan(GPDP) and its alignment with LSDG based 09 themes, allocation of 29 subjects enshrined in the 11th Schedule of Constitution along with mapping of themes, SDGs and departments. During this presentation role of Gram Panchayats in achieving the 09 themes in collaboration with line departments was also made clear. After this Director, PR explained in detail how various departments can share their data base at the bottom level. This was followed by another presentation given by Sh. Sambhav Ramaul NIRDPR representative on Local Indicator Framework(LIF) which are directly linked with LSDGs. During this presentation Local Indicators pertaining to various line departments were demonstrated. Some model GPDPs were also presented. Director, Panchayati Raj asked NIRD representative to share the copies of model GPDPs. Director, PR also instructed that the blocks who have done good work in the formulation of GPDP should also be shortlisted so that the best practices can be replicated.

Director, PR requested all the line departments to verify the indicators, the copy of which was provided to all the participants along with reading material given in the meeting. All the departmental representatives were also requested to nominate the Nodal Officers and share the details of nominated officers on the official mail ID i.e. rgsadir@gmail.com. within one week positively. It was also decided that such meetings be held at the district as well as block level and the State level officers who participated in this meeting are expected to brief their

district and block level officers. The committees in this regard have already been constituted and notified. Instructions to all CEOs(ZP), DPOs and BDOs need to be issued immediately. All the line department officers were also apprised with the guidelines of National Panchayat Awards which are based on 09 themes. Presentation in this regard was also given by Sh. Jayant Khanna, IT consultant. To fill up the questionnaire for participating in the 09 themes based National Panchayat Awards, authentic line department data is required to be shared with the Gram Panchayats. Accordingly all the line departments were requested to share the authentic data at the Gram Panchayat level.

The meeting ended with the vote of thanks.
