**NOTIFICATION**

In exercise of the powers conferred by rule 63 of the Himachal Pradesh Panchayati Raj (Finance, Budget, Accounts, Audit, works, Taxation and Allowances) Rules 2002, the Governor of Himachal Pradesh is pleased to allow the payment of travelling and daily allowances to the office bearers of Panchayat at the following rates and terms and conditions for performing journeys in connection with the affairs of the Panchayat with the approval of the Panchayat with immediate effect :-

- (i) There shall be paid to the office bearer of the Panchayat actual fare and daily allowance for journeys performed by him for any official work within or outside territorial jurisdiction of the concerned Panchayat and such journeys shall not be undertaken unless authorised by a resolution passed to this effect by the Panchayat to which he has been elected:

Provided that he shall not undertake journey outside the State without prior permission of the Director of Panchayati Raj.

- (ii) The actual fare and daily allowance shall be paid only if the journey is performed by him outside a radius of 8 Kilometers from his usual place of residence.
- (iii) The office bearer of Panchayat if using means of conveyance at the expense of the Government or Panchayats or any other authority, as the case may be, shall not be entitled to any travelling allowance.
- (iv) If journey is partly performed by rail and partly by bus, he shall be paid actual railway and bus fare restricted to the class of accommodation to which he is entitled.
- (v) An office bearer of Panchayat shall be entitled to draw single seat fare of class of accommodation to which he is entitled, and if the journey is performed in the lower class then he shall be entitled to the fare actually paid by him.

- (vi) The following shall be the entitlements of travel by public transport and by railway in case of the office bearers of the Panchayats:-

Category of the office bearers of Panchayats	Public transport entitlement	Railway entitlement
1. Chairpersons and Vice-Chairpersons of Zila Parishads	AC Bus	Shatabdi AC Chair Car/AC Two Tier Sleeper/1 <sup>st</sup> Class
2. Members of Zila Parishads and Chairpersons and Vice-Chairpersons of Panchayat Samitis	Deluxe Bus	1 <sup>st</sup> Class/AC Chair Car/AC Three Tier
3. Members of Panchayat Samitis, Pradhans and Up-Pradhans of Gram Panchayats	Deluxe Bus	1 <sup>st</sup> Class (non AC)/ Three Tier
4. Members of Gram Panchayats	Ordinary Bus	2 <sup>nd</sup> Class Sleeper:

Provided that the Railway entitlement shall be admissible only for journeys performed outside the State of Himachal Pradesh.

- (vii) The daily allowance to the office bearers of Panchayats shall be admissible at the following rates:-

Category of the office bearers of Panchayats	Rates of daily allowance
1. Chairman and Vice-Chairman of Zila Parishads	Rs.80/-
2. Members of Zila Parishads and Chairman and Vice-Chairman of Panchayat Samitis	Rs.60/-
3. Members of Panchayat Samitis, Pradhans and Up-Pradhans of Gram Panchayats	Rs.50/-
4. Members of Gram Panchayats	Rs.30/-

- (viii) Subject to the condition specified at Sl.No. (ii), an office bearer of the Panchayat shall be entitled to daily allowance for actual night halt on tour in connection with the affairs of the Panchayat concerned.
- (ix) If an office bearer of a Panchayat, while on tour, is treated as a State Guest, he shall not be entitled to TA and DA.
- (x) No travelling allowance shall be admissible to any office bearer of a Panchayat if the travel expenses are borne by the State Government or other Organizations.
- (xi) No daily allowance shall be admissible to any office bearer of a Panchayat if he is being provided free boarding and lodging facility by the Government or other Organizations.

- (xii) An office bearer of the Panchayat shall also be entitled to local transportation allowance for journeys outside the State @Rs.100/- per day subject to the condition that the reimbursement shall be made after a certificate of actual utilization is given by him.
- (xiii) An office bearer of the Panchayat while travelling by own or hired vehicle shall be entitled for reimbursement of actual railway/bus fare of the class to which he is entitled.
- (xiv) The expenditure on travelling and daily allowances shall be borne by the concerned Panchayat out of its Panchayat fund.
