**Notification**

Whereas the Rural Development Department has notified the creation of ten new Development Blocks namely, Nihri, Dhanotu, Churag in District Mandi, Tilordhar in District Sirmour, Badoh, Palampur, Surani in Kangra District, Bhunter in Kullu District, Kotkhai in Shimla District and Patta in District Solan vide notification No. No. RD(G)1-4/2021 dated 13.08.2021, No. RD(G)1/2-2020 dated 02.08.2021, No. RD(G)1-3/2021 dated 15.09.2021, No. RD(G)1/3-2020 dated 02.08.2021, No. RD(G)1-1/2021 dated 08.11.2021, No. RD-(A)-1/2/2024 dated 15.02.2024, No. RD-(A)-1/3/2024 dated 06.03.2024, No. RD(G)1-7/2021 dated 22.03.2022, No. RD(G)1-2-2021 dated 09.08.2021, No. RD-(A)-1/1/2024 dated 15.02.2024 respectively;

And whereas as per the requirement of section 77 of the Himachal Pradesh Panchayati Raj Act, 1994 (Act No. 4 of 1994) there shall be established a Panchayat Samiti for each Development Block;

Now, therefore, the Governor of Himachal Pradesh, in exercise of the powers vested in him under section 77 of the Himachal Pradesh Panchayati Raj Act, 1994 (Act No. 4 of 1994) is pleased to establish Panchayat Samiti Nihri, Dhanotu, Churag in District Mandi, Tilordhar in District Sirmour, Badoh, Palampur, Surani in Kangra District, Bhunter in Kullu District, Kotkhai in Shimla District and Patta in District Solan for the newly created Development Blocks and the Panchayat Samiti so established shall have the jurisdiction over the entire concerned Development Blocks.

The Governor of Himachal Pradesh, under the provisions of sub section (1) of section 120 of the Himachal Pradesh Panchayati Raj Act, 1994, is further pleased to order that establishment of above ten new Panchayat Samitis shall not affect the term of the present elected office bearers of the Panchayat Samitis whose areas have been merged in the above mentioned newly created Development Blocks and shall continue in existing Panchayat Samiti till the completion of period of five years. The newly established Panchayat Samitis shall start functioning from the date of its first meeting, to be specified by the State Government, under section 120 of the Act *ibid*, after the forthcoming general elections of Panchayati Raj Institutions.


